



# FINANCIAL MARKETS PRACTITIONER LEARNERSHIP BROCHURE

## 1. ASISA ACADEMY VISION & CONTEXT

The ASISA Academy creates and delivers high quality solutions to meet the skills development needs of South African Savings, Life Assurance and Investment Management organisations. Our learning solutions are informed by and responsive to industry realities, delivered in an academically sound and practitioner-led manner. The Academy serves the following three target markets:

1. People already employed by ASISA members and other industry stakeholders to ensure that the skills base within our industry allows us to compete with the best in the world.
2. Young people entering or considering a career in the industry to bridge the gap between the theories learned at university and the realities of the work environment so that students can become work-ready while still studying. Internships form a core part of this offering.
3. Retirement fund trustees and principal officers to raise the levels of their financial literacy.

More than 20,000 people in the Southern African financial services sector have participated in ASISA Academy programmes since 2008, with over 1000 industry presenters involved.

## 2. APPROACH TO LEARNING

Every learning session takes the form of an interactive workshop (online or in person) interspersed with engaging tasks or other learning activities. Our programmes draw deeply on the expertise of some of the most experienced professionals in the industry.

We prefer to limit our class sizes to a minimum of 13 and a maximum of 20 students which allows for a very supportive learning environment in which no committed participant gets left behind. An online learning environment is used where all the presenter resources can be accessed from anywhere at any time. Assessments can also be performed using this online learning environment if required.

### 3. QUALIFICATION DELIVERY

The course content will be based on the newly revised NQF Level 7 qualification the Occupational Certificate: Financial Markets Practitioner (NQF ID 117238). To view the details of this qualification on the SAQA website [click here](#).

Our team of presenters have many years of industry experience as investment management practitioners. They will deliver most of the sessions but also invite industry subject matter experts to present as guest lecturers on their areas of expertise. Given the unique position of the ASISA Academy as an independent non-profit business school we have excellent relationships with many such presenters both within the ASISA members as well as other industry stakeholders such as the JSE and the FSCA.

The academic component of the learnership will be delivered via online 3-hour classroom afternoon sessions (15h30 – 18h30) over 34 sessions. These knowledge sessions will take place over the course of 12 months complementing the practical skills being learned in the workplace. The qualification and learnership culminate in the External Integrated Summative Assessment (EISA) set by the South African Institute of Stockbrokers (SAIS) at the end of the 12-month period.

Delegates will complete the following assessments:

- 9 written practical assignments will be submitted during the course of the programme. These assignments are fully aligned to each of the Practical Modules.
- 13 Multiple Choice Questionnaire tests will be spread throughout the programme to test delegates on the Knowledge modules.
- A Portfolio of Evidence demonstrating the workplace skills components.
- Learners who succeed with all academic assignments, MCQs, and Portfolio of Evidence will be declared ready to write the EISA which is conducted by the SA Institute of Stockbrokers (SAIS) who registered this qualification with the QCTO and who the external examining body.

## 4. LEARNERSHIP

A learnership called the Financial Markets Practitioner learnership is registered against the Occupational Certificate: Financial Markets Practitioner. In terms of the Skills Development BBBEE Codes this programme qualifies as Category D on the Learning Programme Matrix.

From our discussions with SAIS and SETAs, the learnership period is less prescriptive. It needs to be a minimum of 12 months and the EISA must be written at the end of the learnership, however the start and end dates need to be agreed between each employer and the SETA to which you pay your levy. The ASISA Academy will provide some guidance to employers relating to the workplace module of the FMP Qualification which will inform the workplace activities for learners.

This learnership is a FASSET-registered learnership (Learnership code: 01/Q010044/00/120/7). This means that INSETA and FASSET registered employers can apply to their respective SETAs for Discretionary Grant (DG) funding for this learnership.

Delegates who successfully complete this occupational qualification, which is fit for purpose for the investment industry, can apply to the South African Institute of Stockbrokers (SAIS) for an associate membership, which, if approved, they are awarded a SAIS designation.

## 5. FEES

For the programme commencing in 2025 the fees are as follows:

**Academy course fee per learner** **R62,500 + VAT**

Subject to a minimum cohort of 13 learners in total from all participating employers.

In addition to the Academy fee, learnership and exam fees are payable to SAIS and have been estimated by SAIS for 2024 as follows, fees exclude VAT. 2025 fees to be confirmed.

### SAIS fee per learner

- EISA fee per learner R7,185 (2025 fees TBC)

### SAIS fees to register and monitor workplace for learnership purposes

- Workplace assessment fee - Once off per workplace R7,387 (2025 fees TBC)
- Workplace ongoing monitoring – Annual fee per workplace R4,760 (2025 fees TBC)

## 6. FINANCIAL MARKETS PRACTITIONER QUALIFICATION ENTRY REQUIREMENTS

Either an NQF Level 6 qualification in finance or a related field of study OR any other NQF Level 6 qualification with 3 years of relevant assessed work experience in the financial markets.

Learners will also need to have access to a workplace environment in which they can achieve the requirements of the workplace experience module

## **7. FINANCIAL MARKETS PRACTITIONER QUALIFICATION MODULES**
